

# **ENTERING OUR BUILDING IS AGREEING TO CRYSTAL FIELDHOUSE WAIVER OF LIABILITY AND INDEMNITY AGREEMENT RE COVID-19**

This document is in consideration for being permitted to utilize the services and programs in Crystal Fieldhouse building for myself or my children during the time of COVID-19.

Entering our building you are acknowledging the novel coronavirus ("COVID-19") infections have been confirmed throughout the United States, including Michigan.

Entering our building you hereby agree, represents, and warrants that

1. Neither yourself nor children with you shall visit or utilize the facility, services, and programs in Crystal Fieldhouse building within 14 days after (i) returning to this state from out-of-state(ii) exposure to any person returning from out-of-state, or (iii) exposure to any person who has a suspected or confirmed case of COVID-19.
2. Neither yourself nor children with you shall visit or utilize the facilities, services, and programs in Crystal Fieldhouse building if he or she (i) experiences symptoms of COVID-19, including, without limitation, fever, cough or shortness of breath, or (ii) has a suspected or diagnosed/confirmed case of COVID-19.
3. Neither yourself nor children with you agrees to notify Crystal Fieldhouse immediately if he or she believes that any of the restrictions may apply

I acknowledge that Crystal Fieldhouse, in its sole discretion, has established and may further establish and/or modify certain guidelines and protocols for conduct of its clients at its facility and may open, close or reopen its facility at any time and from time to time. I also acknowledge that my conduct is also subject to all federal, state and local guidelines and requirements and that my children (if applicable) and I will follow all such guidelines and requirements. I understand and agree that Crystal Fieldhouse is under no obligation to notify me of the establishment or modification of any of its guidelines and protocols or of any governmental guidelines or requirements. The undersigned fully understands and appreciates both they're known and potential dangers of utilizing the facilities, services, and programs at Crystal Fieldhouse and acknowledges use thereof by the undersigned and/or such participating children (if applicable) may, despite Owners reasonable efforts to mitigate such dangers, result in exposure to COVID-19, which could result in quarantine requirements, serious illness, disability, and/or death.

I am aware that if my children (if applicable) or I violate any of these or any other applicable protocols or guidelines, any of the above mentioned Owners Guidelines and protocols or governmental guidelines and requirements or any other safety precautions deemed appropriate to limit the exposure and spread of disease, my children (if applicable) and I may be asked to leave Crystal Fieldhouse facility and properties on a temporary or permanent basis. I understand that the owner has full and absolute discretion to interpret and enforce all of these protocols and guidelines.

**AS YOU ENTER CRYSTAL FIELDHOUSE BUILDING, YOU AND ANY MINORS WITH YOU (if applicable), RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE** Crystal Fieldhouse, its owners, directors, officers, employees, representatives volunteers and agents from all liability to you or such participating children and all personal representatives, assigns, heirs, and next of kin of the undersigned or such participating children for any loss or damages, and any claim or demands on account of any property damage or any injury to, or an illness or the death of, the undersigned or such participating children (or any person who may contract COVID-19, directly or indirectly, from the undersigned or such participating children) relative to any exposure or potential exposure to COVID-19 or any other illness or injury, whether caused by Crystal Fieldhouse negligence while on the premises, therein or participating in any program affiliated with Crystal Fieldhouse.

I HAVE CAREFULLY READ AND VOLUNTARILY ENTERED CRYSTAL FIELDHOUSE WITH CHILDREN (if applicable). I AM AWARE THAT BY ENTERING THE FACILITY I AM AGREEING TO THIS DOCUMENT I AM GIVING UP VALUABLE LEGAL RIGHTS. I ALSO UNDERSTAND THAT, IF APPLICABLE, THIS AGREEMENT IS MADE ON BEHALF OF MY MINOR CHILD(REN) AND I REPRESENT AND WARRANT TO THE OWNER THAT I HAVE FULL AUTHORITY ON BEHALF OF SUCH MINOR(S).
